BELT AND ROAD COMMITTEE

The Belt and Road Initiative ("The Initiative") launched by the Chinese government aims to promote economic cooperation among countries along the Belt and Road routes to the benefit of all. The Belt and Road Committee ("BRC") was convened at the end of 2015 to explore opportunities arising from The Initiative for members. The BRC set up 4 Subgroups in March to take charge of different areas of its work, namely,: (1) to get updates on government policy on The Initiative; (2) to reach out to overseas law associations covered by The Initiative; (3) to consider possible initiatives to harmonise trade and business law; and (4) to organise joint conferences or events with overseas law associations.

The Law Society actively participated in Belt and Road related conferences / seminars in 2016 and took the opportunities to reach out and promote the Hong Kong legal system and legal profession to other legal professional bodies in countries covered by The Initiative. Four monthly luncheons were organised from August to December to arm members with knowledge or updated information related to regulations, trade and developments of different Belt and Road countries. Consul-Generals and representatives of Chamber of Commerce from Indonesia, Malaysia and Israel were invited to be the luncheon speakers.

The Law Society set up a panel of law firms under the HKTDC Belt and Road Portal to provide one-to-one free investment related advisory service to businesses.

HONOURS COMMITTEE

The Committee met on one occasion. In accordance with the Nomination Guidelines, the Committee considered candidates for admission to the Law Society's Roll of Honour and for admission as an Honorary Member of The Law Society.

At the 2016 Annual General Meeting of the Law Society held in May, upon recommendation of the Honours Committee, the Council admitted Mr. Fred Kan and Mr. Herbert Tsoi to the Roll of Honour of The Law Society.

WORKING PARTY ON LIMITED LIABILITY PARTNERSHIPS ("LLPs")

Part IIAAA of the *Legal Practitioners Ordinance* which introduced limited liability partnerships for law firms in Hong Kong commenced its operation on 1 March. The

Working Party focused its work on introducing the provisions in the legislation to the general membership. The Working Party conducted three briefing sessions on 22 January, 3 February and 5 May. The presentation materials were posted on the website of the Hong Kong Academy of Law Limited ("Academy") accessible to the public for information.

In addition, the Information Packages on LLPs for Hong Kong law firms and foreign law firms as well as pamphlets on LLPs in bilingual text prepared by the Working Party were posted on the Law Society website from 20 January.

The pamphlets on LLPs were also printed and placed at the reception of the Law Society offices for members to distribute to their clients.
